Each registered angler further understands and agrees that this release specifically includes and waives any claims arising from the ARCKDW's use of any photographs and video from the ARCKDW's administration of or interpretation of any polygraph. It is further agreed by all parties that each captain has the ultimate responsibility to determine if conditions are unsafe for his vessel. If each captain is not satisfied that the conditions are safe for his Vessel, that captain shall not participate in the ARCKDW's fishing activities.
